- ☐ Submit official, unopened (sealed) high school or GED transcripts indicating completion of a standard high school diploma or equivalency; **See *Transcripts/Transfer Credit for credit posting deadlines**
- If you completed an A.A.S. degree or higher at an institutionally accredited college and/or university, SPC will not need your high school/GED transcript or Home School Affidavit.*
- ☐ Submit official, unopened (sealed) transcripts from all institutionally accredited colleges and/or universities currently or previously attended (outside of St Petersburg College). **See * Transcripts/Transfer Credit for credit posting deadlines**

Please submit **ALL** transcripts requests 30 days prior to application deadline to ensure they are received and posted to your SPC account by the deadline.

- ☐ Students must demonstrate they are at college level in Writing, Reading, and Math either through appropriate test scores or through appropriate course completion.
Flexible placement eligible students need test scores or appropriate subject course completion.
- ☐ Students must have a cumulative grade point average of 2.00 on a 4.00 scale in all postsecondary coursework. Academic Standing may have an impact on admission, enrollment, and financial aid eligibility. See the SPC Academic Standing Policy for details. [Academic Standing Policy](#)
- ☐ Students must successfully complete all pre-entry requirements within three attempts in accordance with St. Petersburg College Board Procedure: P6Hx23-4.15. Transfer credits, course substitutions, and course withdrawals count as attempts. Withdraw with Refund (WR) grades are not considered.

- Pre-entry Admission course requirements must be completed with a minimum grade of “C” and earn a minimum 2.75 GPA on a 4.00 scale for these courses. All following courses must be completed by the application deadline and are used to calculate the Pre-entry Admission GPA (*exception):
 - BSC 2085/2085L - Human Anatomy and Physiology I and Lab
 - BSC 2086/2086L - Human Anatomy and Physiology II and Lab
 - ENC 1101 or approved Communications Core (May be satisfied by an Associate in Arts or higher degree)
 - *Computer/Information Literacy Competency (May be satisfied by an Associate in Arts or higher degree) no minimum grade, not calculated into the Pre-entry Admission GPA
 - MCB 2010/2010L - Microbiology and Microbiology Laboratory
 - POS 2041 - American National Government or (POS 2041H)
 or AMH 2020 - History of the United States II or (AMH 2020H)
 or AMH 2010 - History of the United States I or (AMH 20100H) – completed fall 2024 or thereafter
 - STA 2023 – Elementary Statistics or (Honors)
- Earn a 2.75 minimum Pre-entry Science GPA on a 4.0 scale in these course requirements: BSC 2085, BSC 2085L, BSC 2086, BSC 2086L, MCB 2010, and MCB 2010L.
- ATI TEAS Test – Completed and posted to your SPC record within 12 months prior to the Nursing Program application deadline (see ATI TEAS test window dates page 1). Find out how to register and request a transcript for the [ATI TEAS Test](#). Retakes are based on [ATI’s minimum standards retake policy](#).
 - Please schedule TEAS exam at least 30 days prior to application deadline to ensure score is received and posted to your SPC account. Missing scores by the application deadline will result in an incomplete application.
 - Upon TEAS Registration: to avoid disruptions to ATI TEAS scores being received and posted to SPC transcript → ensure the following are included in registration steps:
 1. Institution Selection: St. Petersburg College ADN
 2. Name and DOB: matches what is on file with SPC
 3. Student ID: use SPC Student ID Number
 - To confirm posted scores: log into MySPC > My Academics > View Unofficial Transcript > Test Scores
 - Example of TEAS Test Window (per pg. 1): Fall 2027 Term window = May 16, 2026 – May 15, 2027
- Submit the **Health Programs Application** for the Associate in Science in Nursing Program at <https://web.spcollege.edu/hec/application/apply>
 - Applicants are permitted to apply to one track ONLY per application cycle.
 - Preference for the day track (includes either morning theory or afternoon theory schedule), or evening/weekend track will be presented ONLY to those students offered program admission.
IMPORTANT: Evening/weekend track is intended for those who are ONLY able to attend evening/weekend classes. Students selecting this track will not be considered for any other track.
 - Complete **Video Interview and Healthcare Work Experience** submission by application deadline outlined in **Application Confirmation Email**.

***Transcripts/Transfer Credit:** [Submitting Official Transcripts](#)

- To ensure application consideration, ALL official transcripts, test scores, and alternative satisfaction requests must be officially received, evaluated, and posted to your St. Petersburg College transcript/records prior to the application deadline.

Please submit **ALL** transcripts, test scores, and alternative satisfaction requests 30 days prior to application deadline to ensure they are received and posted to your SPC account by the application deadline.

- We do not accept unofficial copies or unsealed official copies.

- Transcripts for course credit earned by exam(s) (e.g., AP, CLEP) must be provided from the originating testing agency.
- **If you have submitted updated transcripts from an institution that SPC has previously received, please verify that your most recent coursework is evaluated and posted to your SPC record.**

***Alternative Satisfaction**

- Transfer courses for which there is no direct SPC equivalent will be posted as elective credit and designated with a number ending in "999"; additionally, upper division (300/3000 level or higher) transfer credits do not automatically post to your SPC record.
- Upper division coursework (transfer or SPC) will not automatically satisfy admission requirements; it must be requested by the student.

If you believe a course posted as an elective should satisfy a degree requirement, or you would like an upper division course be used to satisfy a lower division course, please complete the [Alternative Satisfaction Survey](#)

A copy of your transcript from the former institution and a course syllabus will be required.

Selection Criteria

Due to enrollment limitations, meeting minimum requirements does not guarantee admission. When the number of eligible applications exceeds program availability, selective criteria is used to determine which applicants are offered admission. The College of Nursing determines which applicants will be offered admission utilizing the point values outlined below:

If you are admitted, applicants will need to begin and complete the following pre-enrollment requirements immediately to maintain eligible status.

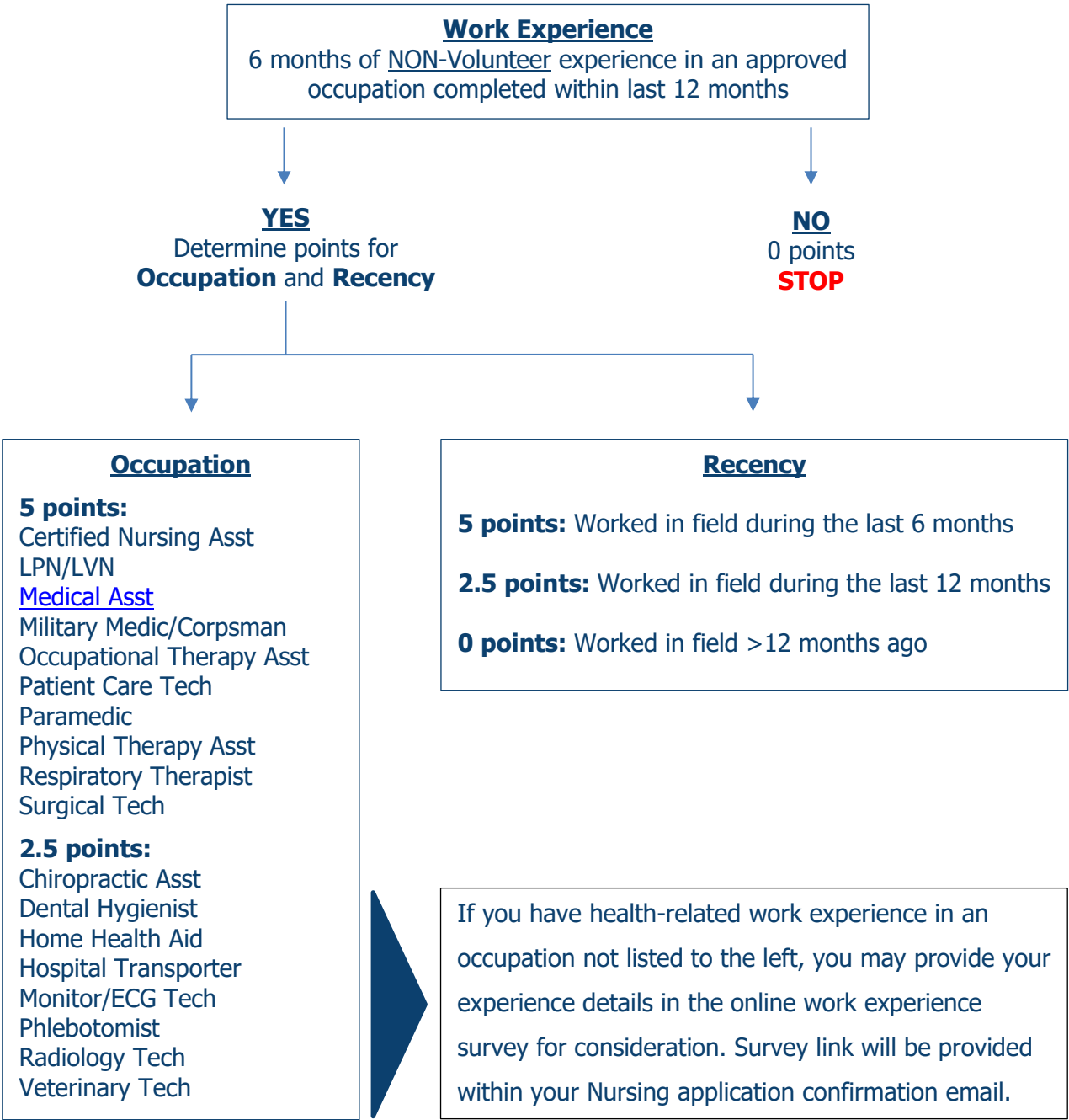
- Complete the Notice of Intent (NOI) survey by the date indicated in the offer of admission email. Track preference selection is included in the NOI, candidates on the Alternate list must submit an Alternate NOI survey for consideration if a seat becomes available.
- Successfully pass a [background check and drug screening](#) by the date indicated in the admission email. (Completion required within 2 weeks following the admission offer)
- Attend the mandatory Health Education Program orientation on the date indicated in the admission email. Please clear your calendar so you are available to attend if you are offered admission; Fall term – mid July, Spring term – mid November, Summer term – mid April.
- Complete the Health Examination Form, all details will be provided during the Nursing Orientation.
- Candidates on the Alternate list must follow instructions and deadlines provided in their admission email to maintain eligibility for possible admission. If you are not notified of being moved from the alternate list to the admit list, a new application will be required during the next appropriate application period.
- If admission offer is declined by the student, a new application will be required during the next appropriate application period; applications do not roll over to future terms.

Work Experience Criteria

The work history criteria is designed to identify applicants with recent and relevant experience in the healthcare field, particularly those who have engaged in direct patient care and interaction. This experience demonstrates a basic understanding of the responsibilities and communication skills essential for success as a nursing student. Additionally, it highlights a commitment to the healthcare profession and a foundational knowledge that can support academic and clinical success.

This applies to RN, LPN-to-RN, and Paramedic-to-RN applicants



Program Information

Clinical facilities may prohibit students who do not have an assigned social security number from participating in clinical experiences which are a mandatory component of the curriculum. If other clinical placement options are not available, students would need to withdraw from the respective semester and would not be able to progress in the nursing program; applicants must take these factors into consideration prior to pursuing admission to the nursing program. Students may be assigned to clinical facilities in Pinellas, Hillsborough, or Pasco counties and must have reliable transportation.

Traditional ASN – Theory/Sim Schedule Tracks:

Please Note: NUR 1110C – Health Concepts I includes Theory, Simulation and Clinical, each are on-campus course sections and held as noted per schedule track options below

For all tracks - *Final practicum course (NUR2940C): The schedule of days/shifts to complete the required hours will vary based on preceptor schedule. (Generally, 3 shifts/wk)*

Morning Track with Weekday Clinicals

- Four consecutive semesters (17 months)
- Theory is in the morning (usually 8am-11Am) - 1 day per week + online coursework
- Simulation is in the morning (usually 7am-1pm) - 1 day every other week
- Clinicals are 1 day per week (M-F, varies) approx. 6am-5pm
- Fall and Spring admission

Afternoon Track with Weekday Clinicals

- Four consecutive semesters (17 months)
- Theory is in the afternoon (usually 1pm-6pm) - 1 day per week + online coursework
- Simulation is in the afternoon (usually 12:30 to 6:30pm) – 1 day every other week
- Clinicals are 1 day per week (M-F, varies) from approx. 6am – 5pm
- Fall and Spring admission

Summer Afternoon Track – Clinical Days Vary - Weekday/Weekend

- Five consecutive semesters (17 months) – practicum completed during 1st 8-weeks of 5th term
- Theory is in the afternoon (usually 1pm-6pm) – 1 day per week + online coursework
- Simulation is in the afternoon (usually 12:30pm-6:30pm) – 1 day per week
- Online simulations – 1 day per week, various weeks
- On-Campus Clinicals weeks 1-3: 2 days per week (M-Sa, varies) from approx. 7am – 1pm
- Clinicals weeks 4-9 – 1 day per week (M-Sa, varies) from approx. 6:30am-2:30pm
- Summer admission

Evening/Weekend Track with Weekend Clinicals (Not Available for Paramedics):

- Six consecutive semesters (2 years)
- Theory is in the evening (usually 5pm-9pm) – 1 day per week + online coursework
- Simulation is in the evening (usually 5pm-8pm) – 1 day per week
- Clinicals are 1 day per week on Saturdays from approx. 6am – 5pm
- Fall and Spring admission
