EXPENDITURES AND CONTRACTS (exceeding \$250,000)

Approval was given by the Board to continue an agreement with Microsoft Licensing, GP at an increased amount to expand and/or implement licensure use for desktop operating systems and other Microsoft products both on College desktops and for work at home.
