B. SPC Spotlights

Dr. Williams shared the following spotlights:

- Applauded the faculty for the upcoming 9th annual Titan Trot, 2/10 Saturday
- SPC had 32 students recognized and placed in the All-Academic team by Florida College System Activities Association, requiring at least 3.3 GPA. They were from student government, softball, men's and women's basketball, women's tennis, and volleyball. - SPC was included in Forbes' Advisor 2023-2024 best affordable early childhood education degree programs online

- SPC study abroad recently ranked 5th in the US, #1 in state community colleges for number of students studying abroad. Two programs last fall: Dental Hygiene in Jamaica and Vet Tech in Africa.
- SPC students participated in the St. Petersbug MLK Day parade.

1. Financial Assistance Services – Mr. Michael Bennett, Associate Vice President, Financial Assistance Services (*Presentation*)

Mr. Bennett presented the following update about Financial Assistance Services:

- Last year, processed 23,148 applications; 9,551 recipients; \$88.2 million total aid
- Up 10% this current year
- Using several ways to answer student questions
- Nationally known for innovation with processing chat BOT, texting, e-forms, and imaging
- 3 years of pandemic CARES funds
- \$230.8K Promise Scholarship at eight area high schools giving students more time to catch up
- FAFSA simplification implementation has not gone well with new terms and formulas. The good news is early modeling resulted in students getting larger Pell grants. FAFSA delayed. The good news is 103 questions down to 46 questions have gone down. As little as 18 questions with skip logic.
- Student loan update: Lowered student borrowing by \$74 million in 12 years. Cohort default rate is down, borrowing less than Pell amount. Big thank you to the board for allowing SPC to partner with I3 group.
- Loan forgiveness: Supreme Court struck down plan in June. Plan would have zeroed out balances for 20 million borrowers. \$132 billion has been forgiven through public service loan forgiveness.
- Some students who borrowed have claimed financial hardship, saying they were illadvised in programs that didn't give financial value. SPC received 59 individual borrower defense claims with 60 day response time. Staff wrote legal briefs on each individual and submitted within 60 days. He thanked the staff.
- He thanked Dr. Williams and the board for creating a regulatory culture. Legal, Finance, Veterans, and FAS are closely aligned and work well together. Expanded assistant

director position to include finance and training. Will Scott has accepted with nine years of compliance experience.

Dr. Williams thanked Mr. Bennett for his leadership, noting that the loan debt ratio was bad and SPC was responsible for that. He and his team have done a tremendous job to help students pay back loans and avoid taking on loans.

Mr. Gibbons thanked Mr. Bennett for an excellent job.

2. Accreditation Update – Dr. Matthew Liao Troth, Vice President, Academic Affairs (*Presentation*)

Dr. Liao Troth shared the following updates:

- SPC is accredited by SACSCOC. Transitioned to baccalaureate institution and distance education through them.
- 10-year cycle, 5th year interim report:
 - o 50 writers
 - o Submitted 9/23
 - Results highlight: SPC managed financial resources in a responsible manner, QEP impact report accepted, referral report due April 1 (not normally seen, re: A typo, then must process through change in state statutes). The typo: In 12/22, SACS updated standard verbiage institutions must have on their websites to include certificates. They made an undocumented changed. Website has been updated, image sent to SACS, they meet in April to approve. Checked every other Florida college and SPC is in the super majority.
 - o Timeline for moving to HLC (higher learning commission): Will receive 5th year approval in April, 2024. Submit that letter to U.S. Department of Education to get permission. Total time 18-24 months.

Mr. Gibbons asked if there will be overlap with the new accreditation rule.

Dr. Liao-Troth replied yes, accreditation with SACS continues until 2028. Hoping for HLC by 2026, so two years overlap.

Mr. Gibbons asked if purchaser of 1 and 2 also has option for purchasing 4 if SPC finds a place available for the College's needs.

Ms. Hunt responded that there may be an option for other parcels. 6 is definite and the team is waiting for the civil engineer to determine other parcels.

Chair Butts opened the Governing Board Meeting at 9:54 a.m.

Ms. Catherine Kennedy shared Collegiate High School highlights:

• Reunification plans: Required to adopt family reunification plan in event a school is closed or unexpectedly evacuated.

She sought approval of the reunification plans. Ms. Cole moved approval. Mr. Gibbons seconded the motion. The motion passed unanimously.

• Referendum fund plans: Pinellas county voters approved half mil property tax to recruit and retain teachers. First approved in 2004, has been repeatedly approved every four years. Current referendum runs through 2024. Received \$450,000+. Plans for each school are included in the board packet: For bonuses and professional development, remaining 20% for visual arts, music, reading, technology. Each eligible staff member will receive supplemental pay and professional development opportunities with the 80%.

She sought approval on the referendum fund plans. Mr. Gibbons moved approval. Ms. Cole seconded the motion. The motion passed unanimously.

• Renewal of SPC and Tarpon Springs charters: Two CHS are renewing charters with the district. Current charter is in the board packet, expiring in June. Application renewal submitted. New contracts will be for 15 years until 2039. Waiting for governor to approve full board.

She invited the principals to share great news:

- Raquel Hairston: STEM update. Seeking institutional accreditation. Site visit March 5 to ensure school meets established quality standards and is committed to excellence and continuous improvement. Currently in recruitment for '24-'25. Will add another 100 students to downtown campus and likely have a waitlist for 9th grade scholars.
- Ian Call: School grades for CHS. All three earned grade of A from Florida including newest STEM that opened just last year. All three received extra funds from the state to be used as supplemental pay for the employees, to be approved by the board. Great success in classroom and building on last year's successes. Gibbs: 97.8% success rate for fall semester. 100% high school graduation rate. In November went to Washington DC to receive national blue ribbon award. Tarpon springs: 98.7% success rate in college classes fall semester. 100% high school graduation rate. Had a national merit scholar. STEM: 97% pass rate in all CIT/Data science courses. 94% pass rate for freshman in college courses. 90% freshmen received GPA of 3.0+.
- Ryan Holstead: Rankings and national merit semifinalists. U.S. News rankings came out and North Pinellas ranked #3 and #4 was South Pinellas. Data taken from state assessments and third parties. In NICHE, a search engine that helps families research schools, Gibbs campus ranked #1 in Pinellas County area. North Pinellas ranked #6. Gibbs campus ranked #1 best charter high school, #1 best public high school, #1 best public high school teachers in all of Tampa Bay area. Proud to announce that Logan Brown and Vivienne Cseh were national merit semifinalists, based on PSAT junior year scores, entering the final round. Potential for financial money.

Chair Butts noted it is fantastic work by the entire team and his excitement about the future of this program. He congratulated them on student expansion and said he is excited to hear the outcome of the national merit semifinalists.

Mr. Gibbons noted this has been a game changer ensuring families can afford college and giving quality education to students. He thanked Governors Bush and Crist and Senator Brandes, who suggested the downtown campus.

Mr. Kidwell thanked the four presenters, noting they have played musical chairs the past few years, assimilated and immediately ascended to the top with big lifestyle changes.

Dr. Williams shared it's miraculous, especially the lives of the students being transformed. As Raquel would say "they come in a little bit different." She thanked Ms. Kennedy for her leadership and work.

Having no further business to come before the Board, Chair Butts adjourned the meeting at 10:08 a.m.




Fall 2023 Student **Profile and** Enrollment **Strategy Impacts**







Summer 2023 Student Success and 2022-2023 Student Success

Summer 2023 Success Rates




2022-2023 Success Rates




Recap - Allstate Program Moves



SUBJECT: U.S. Department of Education—Child Care Access Means Parents in School

Confirmation is sought for a proposal that was submitted, subject to Board of Trustees' approval, to the U.S. Department of Education in support of the St. Petersburg College Child Care Access Means Parents in School (CCAMPIS) program. Permission is sought to accept an estimated \$1,895,136 in funding over a four-year period for this proposal, if awarded, and enter into any amendments, extensions or agreements as necessary, within the original intent and purpose of the grant.

The U.S. Department of Education's *Child Care Access Means Parents in School* (CCAMPIS) program is a multi-year program that works to improve persistence and retention for Pell-eligible students with children. The grant supports childcare vouchers on a sliding scale basis, as well as wrap-around support services for low-income students.

SPC has submitted a proposal to support its voucher-based CCAMPIS program serving Pelleligible students with children. Child care services will be provided through outsourced contracts with licensed and accredited child care providers located throughout the county and Tampa Bay area, ensuring access to child care for students where they live, and supporting students' choice in quality early education providers. Vouchers will be provided on a sliding fee scale, with priority given to full-time students needing full-time child care. The program will also provide significant wrap around support through scholarships, childcare registration fees, life skills and financial literacy workshops, peer support, on-campus events, referrals for basic needs supports and more, to help parents succeed. Through requested CCAMPIS funding, significant leveraged institutional investment, and dedicated partnerships with community agencies, this program will serve an estimated 75 students per year. SPC will leverage the subject matter expertise of the Early Learning Coalition of Pinellas County (ELC), Juvenile Welfare Board and United Way Suncoast by providing cross-referrals for services and support and participating in county-wide child care initiatives.

The estimated period of performance will be from October 1, 2023 through September 30, 2027. The total project budget is projected to be \$1,895,136, of which the College anticipates receiving the full award amount. See attached Information Summary for additional information.

St. Petersburg College's (SPC) *Child Care Access Means Parents in School* program (CCAMPIS) will increase access to critically needed childcare and wrap around services for an estimated 75 low-income students each year. In addition to childcare vouchers, CCAMPIS services will include 1:1 academic and social support from program staff, career and academic advising, financial literacy and life skills workshops, peer support networks, on-campus activities and connections to college and community wrap-around services to meet basic needs. These services will be provided throughout Pinellas county and the Tampa Bay area. Participants will also be eligible for dedicated scholarship funding from the SPC Foundation to defray the cost of attendance and support continued enrollment and degree completion. Program efforts will be led by two full-time CCAMPIS staff as well as leveraged time from: 1) a Student Support Advisor coordinating basic needs services such as laptop lending and food pantries to help high-needs, at-risk students; and 2) Early Childhood Education faculty to provide resources for parents and providers.

Community partners, including Early Learning Coalition, Juvenile Welfare Board and United Way Suncoast, will provide technical assistance in working with providers, referrals for social services, and cross-referrals for childcare assistance. Along with partners, this program leverages significant institutional resources, including: Scholarships from the SPC Foundation, to cover tuition, fees and books, as well as funds to cover events and activities for participants; SPC Match to cover child care registration fees and/or supplemental voucher support; and SPC in-kind match to cover a percentage of staff time for the Student Support Advisor and Early Childhood Education faculty.

With approximately 69% of the total program budget going directly to student support through vouchers, scholarships and childcare registration fees, the program will provide a minimum of 120 childcare vouchers for full- or part-time care and help increase academic success, persistence, retention and completion for participants.

Approval is sought to enter into an Agreement with Rapid7 LLC, either directly or through a reseller, to purchase Security Information and Event Management (SIEM) subscriptions and services.

- The Agreement will commence once signed and will continue for a period of 36 months.
- The total cost for the subscriptions and services to the College covered by this Agreement is \$424,465.00.

A SIEM system aggregates raw logs (i.e., historical records of information processed, recorded, accessed, etc.), notifications, and alerts from various equipment, systems, and sensors; performs correlation of that information based on detection rules; and triggers alerts of different severities based on the configuration of those detection rules. This system provides visibility into real-time threats to improve the time to first detection of a security event and increase the speed at which Information Technology (IT) can respond to those threats to improve the security posture of the College.

The agreement with Rapid7 for a SIEM will provide St. Petersburg College with modern security technology and services. The system will enable the College to perform both machine and userbased analytics to quickly detect when and where a security event is beginning. With this technology, the College will be better equipped to remediate issues as they are developing rather than to be reactionary after an event. This technology will also play a critical role within the College's IT environment as a central repository for audit logs across all systems maintained by internal personnel, including the central computing systems and cloud services environments that host many critical SPC systems such as the PeopleSoft systems (Student, Finance & Human Resources) and Microsoft based email and MS Teams remote collaborative systems. Finally, this system will collect audit logs from all internet and internal firewalls, network sensors, and endpoint security applications to further assist the College's response to an event.



Palladium Board Report September 2023

- 1. The Palladium's first season was 1998. Our 2023 season marks the theater's 25th anniversary. We will celebrate the anniversary and kick off the \$10 million Capital Campaign for theater renovation on October 25th with a gala event in Hough Hall and the Side Door.
- 2. The design contract for the Palladium Renovation was approved. The design team visited the Palladium on Friday, August 18th for a walk-thru for a new member of the design team. The entire team returns on September 6 and 7 to start work. SPC Facilities is coordinating that visit.
- 3. The Palladium's summer of sell-outs continues. We sold all seats for the Summer Jam show on Saturday, August 19th and all seats for our Side Door show on August 25th. We had more than 400 in attendance for a Clearwater Jazz Holiday fundraiser on August 18th and our bossa nova show on Saturday, August 26th.
- 4. Palladium was nominated for a Best of the Bay award as Best Performing arts venue.
- 5. The Palladium scored 96.3 on the City of Saint Petersburg arts grant application in 2022, the highest score of all applicants. Because of that score, the Palladium did not have to reapply in 2023 and was awarded more than \$21,000 in this grant cycle.
- 6. The Palladium also received a \$5,000 grant from the Bailey Foundation to produce the premier performance of a chamber music work based on the mangrove trails at Weedon Island. The composer teaches at the University of Florida.
- 7. Applications for our 2023-24 class of Creative Fellows set a record for applicants. A Palladium committee will select the new class in September and will make the announcement this fall.




The FY22-23 fund 1 operating budget report through June 30, 2023, is attached.

As of June 30, 2023, the overall revenue was \$157.76M, which represents 96.16 % of the operating budget. The overall expense was \$145.49M, which represents 88.68 % of the operating budget. Personnel expenses represent 73.84 % of the annual operating budget. As of this report date, personnel expenses total \$106.6M or 88 % of the total budget of personnel expenses. Instructional personnel expenses account for \$83.4M and \$23.2M for Administration personnel expenses total \$12.27M; which includes loss of revenue recovery and excludes net pension adjustments.




Displayed below are charts for projected tuition revenue. There are three types of tuition revenue: credit tuition, non-credit tuition, and postsecondary adult vocational tuition.







